Important: Admission will be confirmed only after verification of the required documents, eligibility and completion of the prescribed admission formalities.

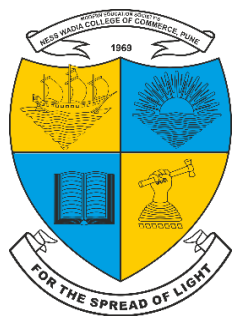

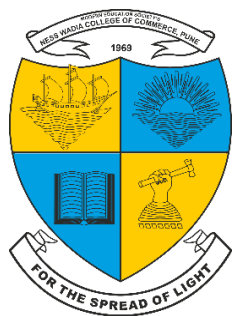

Students should complete the online admission form by entering the required:

- **Personal Details** – Name, Date of Birth, Gender, Address, Category, Mobile Number and Email ID
- **Academic Details** – SSC/HSC Marks, Board Details and School / College Information
- **CAP Admission Details** – CAP Application ID, CAP Round and other required details
- **Programme Details** – Programme allotted through CAP

Students must ensure that all information entered is **correct and matches the supporting documents**.

- Passport Size Photograph
- Any other applicable supporting document

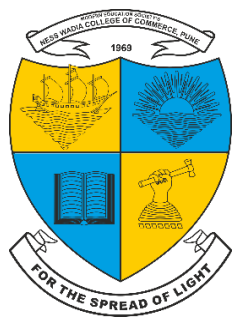
Students must ensure that the uploaded documents are **clear, complete and valid**.

4. Submit the Admission Form and Complete Document Verification:

After completing the online form and uploading the required documents, students should:

- Verify all details and uploaded documents.
- Submit the **Online Admission Form**.
- Download and take a printout of the submitted Admission form.
- Sign the form wherever required.
- Submit the **printed and signed form along with Original and self-attested photocopies of the required documents** to the College Administration Office.

After successful payment, students should **download and save the fee payment receipt** and submit / produce a copy to the College, if required.

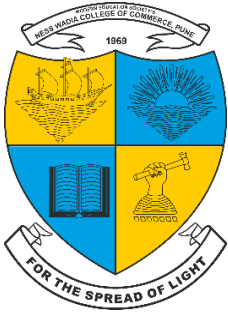
7. Completion of Admission Process:
