Eligibility

(As per the GR Dated 07th Oct 2017, 22nd Feb 2018, 01st March 2018, 18th June 2018, 11th July 2019)

- Applicant should have Nationality of India.
- Candidate should be Domicile of Maharashtra State.
- Applicant should be "Bonafide Student of Institute" and admitted for Professional and Technical courses (Graduation) as mentioned in GR.
- Deemed University and Private university are not applicable.
- Candidate should be admitted through Centralized Admission Process (CAP).
- Applicant should not avail any other scholarship/stipend.
- For current Academic Year, only 2 children from the family are allowed for the benefit of the scheme.
- The Total Annual Income of Family / Guardian should not be more than 8 Lakhs.
- Minimum 50% attendance in the previous semester (Exception for freshly admitted students in College).
- During the course duration, the candidate should not have a gap of 2 or more years.
- Candidates are eligible if they have taken admission under the General category and SEBC Category.

Documents Required

- Mark sheet of 10th (S.S.C) & onwards.
 - Domicile Certificate of Maharashtra State.
 - Register Labor Certificate / Alpbahudharak (Marginal Land Holder) Certificate. (In case of not a child of Alpbahudharak or Registered Labour, then a Family Annual Income Certificate is required (24-25)).
 - Undertaking stating "In current year, not more than 2 beneficiaries from the family".
 - CAP-related document.
 - Hosteller documents (In case of private hostel or Paying Guest, an agreement with the owner will be required).
 - Non - Creamy Layer certificate.
 - fee receipt Xerox copy, Adhar card Xerox copy, Bank Pass book,Xerox copy
- *Form duly filled in should be submitted to the office at Counter No. 3 with all required documents.**
