Eligibility

(As per the GR Dated 07th Oct 2017, 22nd Feb 2018, 01st March 2018, 18th June 2018, 11th July 2019)

- a) Applicant should have Nationality of India.
 - b) Candidate should be Domicile of Maharashtra State.
 - c) Applicant should be "Bonafide Student of Institute" and admitted for Professional and Technical courses (Graduation) as mentioned in GR.
 - d) Deemed University and Private university are not applicable.
 - e) Candidate should be admitted through Centralized Admission Process (CAP).
 - f) Applicant should not avail any other scholarship/stipend.
 - g) For current Academic Year, only 2 children from the family are allowed for the benefit of the scheme.
 - h) The Total Annual Income of Family / Guardian should not be more than 8 Lakhs.
 - i) Minimum 50% attendance in the previous semester (Exception for freshly admitted students in College).
 - j) During the course duration, the candidate should not have a gap of 2 or more years.
 - k) Candidates are eligible if they have taken admission under the General category and SEBC Category.
