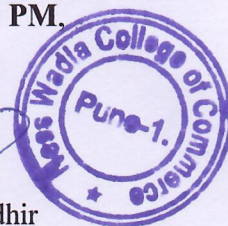
#### II. Rules for Examination Form Submission:

1. All SY, and TY B.Voc. students (both regular and backlog) must **submit** the exam form for their respective semesters (1st to 6th).
2. **Hard copies** of the examination forms are available at the **BBA Administration Office**.
3. **Second, and Third Year students** must submit a **photocopy of their Admission Fee Receipt** and **last semester/year marksheet** along with the exam form.
4. After filling out the form, students must get it **verified by the B.Voc. Nodal Officer Prof. Ashwini Waghmare**.
5. Forms **submitted after the End Date** will **not be accepted**.
6. Following verification, students can pay the fees online at [ness.vriddhionline.com](http://ness.vriddhionline.com) using their student profile (under the "Pay Miscellaneous Fees" tab). Assistance is available at the **BBA Administration Office** if needed. **The examination fee structure is enclosed herewith for your reference.**
7. After payment, students must submit the **hard copy of the examination form** along with **2 copies of the online payment receipt** to the **BBA Administration Office**. It is the student's responsibility to ensure that the hard copy is submitted; failure to do so will result in **ineligibility to appear for the examination**, even if online payment has been made.
8. Examination forms will be accepted **only between 10:30 AM and 01:00 PM**, excluding holidays.
9. **The College will be closed on the 2nd and 4th Saturdays** of each month.

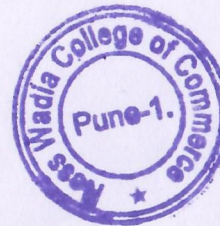
