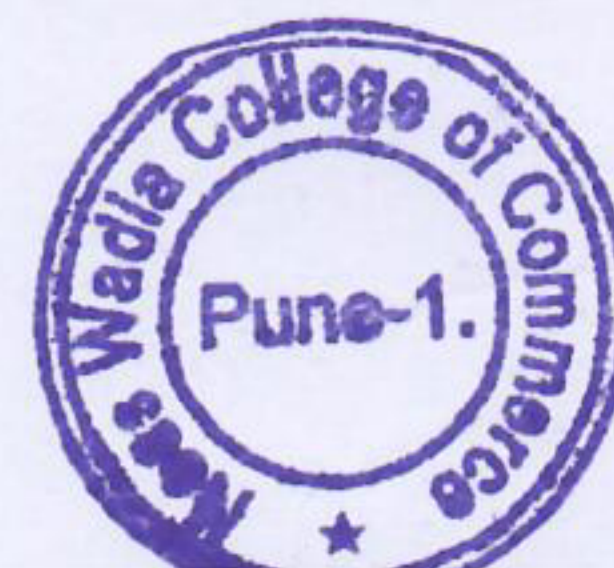



Important Instructions:

1. Students must report to the examination venue at least **15 minutes before** the scheduled time and carry their **College Identity Card and Hall Ticket**.
2. Students must bring their **Field Visit Report** and other relevant supporting documents, if any, at the time of the Viva Voce Examination.
3. The Field Visit Report shall be based on the student's study and observation visit to International Business agency or its branch office, World Trade Centre, Foreign Commercial Consulates, Indent Houses, and Shipping Cos. Branch of Foreign banking Co. IIFT, etc.
4. Only those students who have submitted the **Field Visit Report** shall be permitted to appear for the Viva Voce Examination.
5. The Field Visit Report and Viva Voce Examination shall be assessed by a panel consisting of **one Internal Examiner and one External Examiner** appointed as per University norms.
6. Students shall maintain proper discipline and comply with all instructions issued by the College authorities during the examination process.
7. Absence from the Viva Voce Examination shall be treated as absence for Subject Code **105 – Field Visit Report and Viva Voce**, and no separate Viva Voce Examination shall be conducted.
